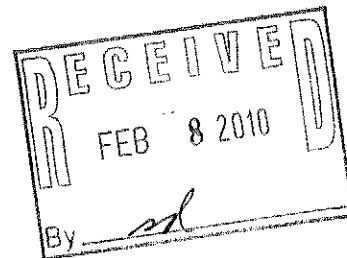

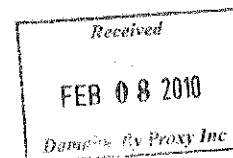

The domain name "iukagac" is registered through the GoDaddy registration services by Domains By Proxy and it appears that the site is hosted by Wild West Domains.

You are requested to immediately have your liability insurance carrier contact the undersigned with regard to the damages caused by the above-referenced wrongful acts, and to immediately take down the defamatory and misleading web pages in question.

You are further advised that you should take all necessary steps to preserve evidence of the website including, but not limited to, html and xml code, scripts, all html files, logs, images, ftp logs and files, messaging and readers' comments files, scripts and access logs, service agreements, license agreements, account information, applications, correspondence, email, and other electronically stored information as well as hard copies of any and all data or documents connected with the website, web pages, domain, name servers and/or hosting services.

This is also to request that you immediately disclose the name(s) and contact information of every individual who contracted for or performed work on the web pages displayed on the www.iukagac.com website or with whom either of you contracted to supply proxy registry information or hosting services. If these requests are not met or you do not otherwise respond within ten (10) days of the date of this letter, then appropriate legal action against you will be taken in the United States District Court for the Northern District of Mississippi.
